

Conditions of Entry

The following Conditions of Entry apply to, but are not limited to, all person present at any FISAF Australia event.

Tickets & Wristbands

- All spectators must purchase a ticket and collect a valid wristband on arrival to be eligible to enter the competition venue.
- Wristbands must remain attached at all times during the event. Any wristband that is removed during the event will immediately become void, and a new ticket will need to be purchased.
- Staff have the right to deny entry to any spectator not wearing a wristband, or whose wristband has been tampered with.

Refusal of Entry

FISAF Australia reserves the right to refuse entry to/of:

- any person/s deemed to be intoxicated and/or disorderly
- any person/s who display offensive, discriminatory or anti-social behaviour. Such behaviour during events will not be tolerated, and may result in offending person/s being asked to leave.
- any unauthorised persons
- any items which have the potential to cause injury or public nuisance

Photography / Film

- Due to child safety protocols, taking photos and videos from the spectator seating area is prohibited.
- Spectators are only permitted to take photos/videos of their OWN child, and must do so from the Designated Photography Areas only.
- Coaches are only permitted to take photos/videos of athletes from their OWN club/school.
- Once spectators have finished taking photos/videos their child, they must leave the designated photography area as a courtesy to the other spectators also wishing to capture photos/videos.
- Flash photography is strictly prohibited.
- Capturing photographic, and film images at a FISAF event for commercial purposes is not permitted.
- Any person suspected of taking photos/videos of a person/s other than their own child may be asked to delete said photos/videos, and may be requested to leave the venue.

General Conditions

- Alcoholic beverages are not permitted to be brought into the event venue.
- Smoking is only permitted in designated smoking areas as identified by the venue.
- Any person who brings personal items into a venue does so at their own risk. The venue and FISAF Australia will not take responsibility for any damage, loss or theft of a person's personal property, and are released of any claims regarding such.
- In the event of an emergency evacuation all persons must follow directions given to them by FISAF Australia or venue staff.
- Strollers and prams are permitted into the venue but must be kept to the side or back of the seating area so as not to pose a safety hazard to others
- At no time is a spectator to enter unauthorised areas of the venue (such as warm-up space or backstage) without the express permission of a FISAF Australia staff member. If permitted into one of these areas, the spectator must be accompanied by a FISAF Australia staff member at all times. Breaches to this condition are considered serious offences by FISAF Australia and dealt with as such.

Liability Waiver

All persons attending a FISAF Australia event release, waive, discharge, absolve, indemnify, agree to hold harmless FISAF Australia of any claim arising out of an injury to themselves (or their minor/ward) and from any claims, causes of action, obligations, lawsuits, charges, complaints, damages, costs or expenses of any kind, nature, or description, whether direct or indirect, in law or equity, in contract or tort, or otherwise. This includes whether known or unknown, arising out of or connected with their own (or my minor/ward) attendance at and participation in the FISAF Australia events, whether or not caused by FISAF Australia's negligence or gross negligence.
